**RECONSTITUTION RATIO:**

Although the end usage, process, size and style of cut will ultimately dictate the correct ratio, pumpkin generally require three (3) to five (5) parts water (by weight) to one (1) part pumpkin, to fully reconstitute. Pumpkins return to fresh cut dimensions when reconstituted.
